GOA YUVA SAMVAD YOJAN SCHEME

Government of Goa hereby notifies the "Goa Yuva Samvad Yojan Scheme" as under:—

Preamble to the scheme.— In the budget speech for the year 2016-17; in line with the Digital India initiative of the Government of India, Government of Goa had promised to come up with a digital youth initiative for the youth of the state. This would be a plan wherein the youth would get free voice as well as data access in order to make the digital revolution inclusive and accessible to the youth of the state so that a level playing field of opportunities is created.

The availability for data access would help the youth gather vital information to help overall development with a focus on education and skill development. The scheme would specifically be more useful to the rural youth who today is out of the digital India paradigm due to non availability of internet access. It will also help the youth to connect with the peers across the state and countries and increase their knowledge base in terms of education, carrier opportunities and skill development.

Keeping these objectives in mind the Government has proposed the Goa Yuva Samvad Yojan Scheme.

I. *Short title and commencement.*— (1) This scheme shall be called "Goa Yuva Samvad Yojan".

II. *Benefits under the scheme.*— (1) The beneficiaries under the scheme shall be eligible for the following "Monthly Free Pack":—

(*a*) Free Local 100 minutes Voice calls.

(*b*) Free 3GB 3G/4G data pack with 2Mbps download speed.

(c) Free SIM card [one time].

(2) The above benefits will be given every month to each registered beneficiary of the scheme.

(*3*) The benefits under this scheme are limited within Goa.

III. *Eligibility and other conditions.*— (1) Any youth who fulfils all of the following conditions are eligible to apply:-

(*a*) The youth who attains the age of 16 years on or after 1st April, 2016 or who is less than equal to 30 years as on date of registration minus 6 months, may apply for the scheme;

(*b*) Resident of Goa for the last five years;

(*2*) If any doubt arises regarding eligibility of any, the same shall be decided by a Committee consisting of the following:-

(a) Secretary to Government of Goa in charge of Department of Information Technology,

(*b*) Additional/Joint Secretary to Government of Goa in charge in the Department of Finance as Member, and

(*c*) Director, Department of Information Technology as Member Secretary.

(*3*) The decision of the above Committee shall be final and binding. No appeal or request for reconsideration of decision shall be allowed under the scheme.

IV. *Mode of operation.*— (1) Government of Goa would identify a GSM Mobile Service Provider to execute this scheme for the State.

(2) The charges towards the above service would be paid by Government of Goa to the selected GSM Mobile Service Provider on a monthly basis.

(*3*) For the purpose of operation of this scheme through the GSM Mobile Service Provider concerned, M/s Goa Electronics Limited (GEL) (Implementation Agency), shall execute a Memorandum of Understanding (MoU), detailing the terms and conditions of operation of the GSM Mobile Service Provider.

V. *Application procedure.*—The applicant may apply for the scheme, in the prescribed form ["Annexure I"].

The Mobile Service Provider may add any other fields as per the requirement of TRAI/ /DoT. The application complete in all respects, along with one passport size photograph and the following documents has to be submitted to avail the scheme:-

(1) Aadhar Card.

(2) Proof of Age: Self Attested copy of any one of the following documents showing proof of age between 16-30 years; Voter ID (EPIC)/ /Driving Licence/Birth Certificate/Passport/ /School Leaving Certificate.

(*3*) *Proof of 5 years residence in Goa*: Any one of the following documents; EPIC Card/Driving Licence/Passport issued before 31st March, 2011 or Residence Certificate showing 5 years residence in Goa.

The scheme application form will be made available at minimum 500 retailer outlets of the selected GSM mobile service provider across Goa. The scheme application form can also be submitted online along with the scanned copy of the documents. The applicant will be given an acknowledgement number which can be used to track the status of the registration towards the scheme.

Note 1: Aadhar Card will be compulsory for all applicants.

2: The application form (Annexure-I) shall be serially numbered and issued. Application forms in any other format or proforma or reprographic copies of the same shall not be accepted.

VI. *Scheme details.*—(1) The scheme will be available in prepaid connection only.

(2) The Mobile Service Provider will not charge any fee to the subscriber for the Monthly Free Pack approved by the Government of Goa. Any additional usage by the user over and above the defined Monthly Free Pack will have to be borne by the beneficiary by topping up the additional balance.

(*3*) The Mobile Service Provider will set up minimum 500 activation outlets/retailers for the citizens to apply towards the Goa Yuva Samvad Yojan Scheme across Goa. There will be minimum one outlet in each of the village/town in Goa. The list of the outlets along with name, contact number, Taluka and village details will be available on the website and mobile app.

(4) The application duly filled and complete in all respect, received, shall be scrutinised and sanctioned by the Government of Goa, in the order in which application is received.

(5) After activation of the plan the beneficiary will get the relative quota towards monthly free pack every month.

(6) The scheme will be automatically deactivated if the beneficiary crosses the 30 year age mark.

(7) The beneficiary can use the mobile app towards the scheme to know the scheme details, check the speed, submit complaint or cancellation request, and track application status. The app will also facilitate latest happenings and announcements.

(8) Aadhar based e-KYC authentication of the applicant will be done.

(9) Government will have facility to push notifications to the closed user group under this scheme.

(*10*) The services under this scheme are non transferrable.

(11) The abusive/offensive/unlawful usage of the plan under this scheme will be liable for discontinuation of the scheme benefits.

(*12*) The disbursement of benefits under this scheme shall be subjected to the availability of funds provided for the purpose annually by means of budgetary support.

VII. Cancellation of benefits towards the scheme.— The benefits under this scheme can be cancelled/deactivated either on request of

the applicant or if the beneficiary crosses 30 year age mark or if the beneficiary is identified in making unlawful/abusive/offensive usage of the services. The registered beneficiary will have facility to submit the cancellation application through the mobile app.

VIII. *Power to relax.*— (1) For removal of any difficulties in the implementation of the scheme, there shall be a four member Committee constituted as in clause III (2) above.

(*2*) The decision of the Committee shall be final and binding on all concerned.

(*3*) The Government shall have the power to amend, modify and cancel any part or whole of the scheme at any time.

5. *Power to relax.*— Where, the Government is of the opinion that it is necessary or expedient so to do, it may, by order, for reasons to be recorded in writing and in consultation with the Goa Public Service Commission, relax any of the provisions of these rules with respect to any class or category of persons.

6. *Saving.*— Nothing in these rules shall affect reservations, relaxation of age limit and other concessions required to be provided for Scheduled Castes and other special categories of persons in accordance with the orders issued by the Government from time to time in that regard.
