Awareness towards healthy food, ecology and pollution free environment is encouraging farmers in practicing organic farming and aims at production of quality and safe products containing no chemical residues by following eco-friendly production methods and system that restores and maintains soil fertility.

Above aspects necessitates to promote organic farming which offers long term benefits to environment and community health by decreasing the use of chemical fertilizers and pesticides with focus on improving soil health through biological system to supply fertility and pest control rather than chemical input. Organic agriculture does't just benefit one family, it helps all families live life with less harmful chemicals.

Therefore the Government is pleased to launch and notify a scheme for the same as under:—

1. *Short title & commencement.*— (i) The scheme shall be called as “Assistance for use of Organic Inputs by the Farmer.”

(ii) This scheme shall come into force from the date of its notification in the Official Gazette and shall be in force till the same is amended or terminated by the Government.

2. *Objective of the scheme.*— (i) To make environment safe and pollution free and to protect the health of human beings and animals.

(ii) To provide critical inputs required for organic farming.

(iii) To reduce the use of chemical fertilizers and pesticides.

(iv) To promote organic farming through use of organic inputs and conversion of agricultural fields into organic farms.

(v) To enhance farmers income through production of quality produce.

3. *Components of the scheme.*— The scheme would be implemented with following components:—

(i) Assistance to the extent of 50% of the cost of Organic Input used by Goan farmer in their fields/farms.

4. *Eligibility.*— (i) Any farmer possessing a valid Krishi Card and cultivating a minimum area of 0.1 hectare and carrying out agricultural activities in the State.

(ii) Farmer should possess a Soil Health Card not older than 2 years period.

(iii) The organic inputs permitted under the Indian Standard i.e. IS 16550 (Part): 2016 BUREAU OF INDIAN STANDARDS, New-Delhi www.Bis.org.in/www.standardsbis.in shall be considered for the assistance.

5. *Pattern of assistance.*— (i) 50% Assistance on cost of organic inputs limited to Rs. 10,000 per hectare and maximum upto 2 hectares or Rs. 20,000/- per beneficiary for all categories of farmers on use of organic inputs as below:—

(a) Organic fertilizers such as organic manure of plant origin, Vermi-compost, Press mud, Mushroom waste, Neem cake, Groundnut cake, etc.

(b) Bio-fertilizers such as Rhizobium, Azotobacter, Azospirillum, Acetobacter, Nitrogen fixing bio-fertilizers, Phosphate solubilizing bio fertilizers, Potassium mobilizing bio-fertilizer, Zinc solubilizing bacteria Compost Inoculants, etc.

(c) Bio-Pesticides such as Tricoder-maspp, Beauveriabassiana, Verticillum, Noumeria, Bacillus spp, Pseudomonas fluorescens, Neem based, EM based, Plant extracts based, etc.

(d) Bio-Control Agents.

The assistance provided by Government of India towards above programme under any other scheme would be adjusted within the total subsidy and balance subsidy shall be paid by the State Government.

6. *Guidelines and procedure.*—(i) The farmer shall submit their application along with the

Krishi Card Abstract, Soil Health Card, cash invoice towards purchase of inputs under the scheme to the Zonal Agriculture Officer.

(ii) Bill of Commercial units registered/ licensed with the Department of Agriculture producing organic manure of plant origin/ Vermi-compost and whose units have not been subsidised by this Department and who issue a valid cash invoice will be eligible.

(iii) The Zonal Agriculture Officer would scrutinize the case for the documents (1) Krishi Card, (2) Soil Health Card, (3) Certificate on bill stating that the items/inputs are permitted under IS 16550 (part 1): 2016, (4) Site Inspection Report and then only submit the case to the District Agricultural Officer North/South for sanction and payment.

(v) The subsidy will be disbursed to the applicant farmer only through Electronic Clearance System (ECS).

7. *Relaxation.*— The Government shall be empowered to relax any or all clauses or conditions of the scheme in genuine cases. However, for release of financial assistance in such case will be considered only with the approval of Finance (Exp.) Department.

8. *Interpretation.*— If any question arises regarding interpretation of any clause, word, expression of the scheme, the decision shall lie with the Government, which shall be final and binding on all concerned.

9. *Redressal of Grievances and Disputes.*— Grievances if any, arising out of the implementation of this scheme, shall be heard and decided by the Minister for Agriculture and the decision of the Minister of Agriculture in this regard shall be final and binding on all concerned.

Read: Notification No. 1-29-2013-14/PLG/RCS/568 dated 2-7-2013 published in the Official Gazette, Series I No. 15 dated 11-07-2013.

Whereas the Government has notified a scheme called “Infrastructure Development Scheme for Dairy Co-operatives” by way of grant to meet the administrative/managerial expenses on staff salaries and allowances, wages, office expenses, rent rates and taxes, and equipments for their development/smooth functioning of business and other allied activities.

And whereas the Dairy Co-operative Societies who are regularly supplying the milk to the Milk Union shall be entitled for the financial support in the form of grant on the following pattern on yearly basis.

Sr. No.	Daily collection of Milk	Grant entitled
1.	Above 500 liters per day	Rs. 1,50,000/-
2.	300-500 liters per day	Rs. 1,00,000/-
3.	150-300 liters per day	Rs. 75,000/-

And whereas Government considers it necessary to carry out certain amendment under the scheme since the Dairy Co-operatives supplying less quantity of milk are not benefitted. Therefore the Dairy Co-operative Societies who are regularly supplying the milk below 150 liters per day to the Milk Union are also required to be brought under the scheme.

Now, therefore, Government is pleased to amend the scheme and pattern of financial assistance for their development/smooth functioning of business and other allied activities shown at Clause No. 4 as below:—

4. *Pattern of Financial Assistance.*— The Dairy Co-operative Societies who are regularly supplying the milk to the Milk Union shall be entitled for the financial support in the form of grants on the following pattern on yearly basis subject to availability of funds.

Sr. No.	Daily collection of Milk	Grant entitled
1.	Above 500 liters per day	Rs. 1,50,000/-
2.	300-500 liters per day	Rs. 1,00,000/-
3.	150-300 liters per day	Rs. 75,000/-
4.	50 to 150 liters per day	Rs. 30,000/-

Whereas, certain draft rules further to amend the Goa, Daman and Diu School Education Rules, 1986, were pre-published as required by sub-section (1) of section 29 of the Goa, Daman and Diu School Education Act, 1984 (Act No. 15 of 1985), in the Official Gazette, Series I No. 2, dated 15-04-2016, vide Notification No. DE/Acad/Misc./Amendment--Rule/2015 dated 11-04-2016 of the Department of Education, Art and Culture, Directorate of Education, inviting objections and suggestions from all persons likely to be affected thereby within a period of fifteen days from the date of publication of the said Notification in the Official Gazette;

And whereas, the said Official Gazette was made available to the public on 15-04-2016;

1. *Short title and commencement.*— (1) These rules may be called the Goa School Education (Amendment) Rules, 2016.

2. *Amendment of rule 88.*— In rule 88 of the Goa, Daman and Diu School Education Rules, 1986, in sub-rule (1), in the proviso,—

(i) for the words “shall be granted extension”, the words “may be re-employed” shall be substituted;

(ii) for the words “such extension”, wherever they occur, the words “such re-employment” shall be substituted.

to provide for the authorisation of appropriation of moneys out of the Consolidated Fund of India to meet the amounts spent on certain services during the financial year ended on the 31st day of March, 2013, in excess of the amounts granted for those services and for that year.

Be it enacted by Parliament in the Sixty-sixth Year of the Republic of India as follows:—

1. *Short title.*— (1) This Act may be called the Appropriation (No. 4) Act, 2015.

2. *Issue of Rs. 4921,06,27,472 out of the Consolidated Fund of India to meet certain excess expenditure for the year ended on the 31st March, 2013.*— From and out of the Consolidated Fund of India, the sums specified in column 3 of the Schedule, amounting in the aggregate to the sum of four thousand nine hundred twenty-one crore, six lakh, twenty-seven thousand four hundred seventy-two rupees shall be deemed to have been authorised to be paid and applied to meet the amounts spent for defraying the charges in respect of the services specified in column 2 of the Schedule during the financial year ended on the 31st day of March, 2013, in excess of the amounts granted for those services and for that year.

3. *Appropriation.*— The sums deemed to have been authorised to be paid and applied from and out of the Consolidated Fund of India under this Act shall be deemed to have been appropriated for the services and purposes expressed in the Schedule in relation to the financial year ended on the 31st day of March, 2013.

(AMENDMENT) ACT, 2015

ACT

further to amend the Payment of Bonus Act, 1965.

Be it enacted by Parliament in the Sixty-sixth Year of the Republic of India as follows:—

1. *Short title and commencement.*— (1) This Act may be called the Payment of Bonus (Amendment) Act, 2015.

(2) It shall be deemed to have come into force on the 1st day of April, 2014.

2. *Amendment of section 2.*— In section 2 of the Payment of Bonus Act, 1965 (hereinafter referred to as the principal Act), in clause (13), for the words “ten thousand rupees”, the words “twenty-one thousand rupees” shall be substituted.

3. *Amendment of section 12.*— In section 12 of the principal Act,—

(i) for the words “three thousand and five hundred rupees” at both the places where they occur, the words “seven thousand rupees or the minimum wages for the scheduled employment, as fixed by the appropriate Government, whichever is higher” shall respectively be substituted;

(ii) the following *Explanation* shall be inserted at the end, namely:—

Explanation.— For the purposes of this section, the expression “scheduled employment” shall have the same meaning as assigned to it in clause (g) of section 2 of the Minimum Wages Act, 1948.’.

4. *Amendment of section 38.*— In section 38 of the principal Act, for sub-section (1), the following sub-section shall be substituted, namely:—

“(1) The Central Government may, subject to the condition of previous publication, by notification in the Official Gazette, make rules to carry out the provisions of this Act.”.

(AMENDMENT) ORDINANCE, 2016

No. 4 of 2016

Promulgated by the President in the Sixty-seventh Year of the Republic of India.

An Ordinance further to amend the Indian Medical Council Act, 1956.

Whereas Parliament is not in session and the President is satisfied that circumstances exist which render it necessary for him to take immediate action;

Now, therefore, in exercise of the powers conferred by clause (1) of article 123 of the Constitution, the President is pleased to promulgate the following Ordinance:—

1. *Short title and commencement.*— (1) This Ordinance may be called the Indian Medical Council (Amendment) Ordinance, 2016.

(2) It shall come into force at once.

2. *Insertion of new section 10D.*— In the Indian Medical Council Act, 1956 (hereinafter referred to as the 102 of 1956. principal Act), after section 10C, the following section shall be inserted, namely:—

“10D. *Uniform entrance examination for undergraduate and post-graduate level.*— There shall be conducted a uniform entrance examination to all medical educational institutions at the undergraduate level and post-graduate level through such designated authority in Hindi, English and such other languages and in such manner as may be prescribed

and the designated authority shall ensure the conduct of uniform entrance examination in the aforesaid manner:

Provided that notwithstanding any judgment or order of any court, the provisions of this section shall not apply in relation to the uniform entrance examination at the undergraduate level for the academic year 2016-2017 conducted in accordance with any regulations made under this Act in respect of State Government seats (whether in Government medical college or in private medical college) where such State has not opted for such examination.

3. *Amendment of section 33.*— In section 33 of the principal Act, after clause (ma), the following clause shall be inserted, namely:—

“(mb) the designated authority, other languages and the manner of conducting of uniform entrance examination to all medical educational institutions at the undergraduate level and post-graduate level;”.

ORDINANCE, 2016

No. 5 of 2016

Promulgated by the President in the Sixty-seventh Year of the Republic of India.

An Ordinance further to amend the Dentists Act, 1948.

Whereas Parliament is not in session and the President is satisfied that circumstances exist which render it necessary for him to take immediate action;

Now, therefore, in exercise of the powers conferred by clause (1) of article 123 of the Constitution, the President is pleased to promulgate the following Ordinance:—

1. *Short title and commencement.*— (1) This Ordinance may be called the Dentists (Amendment) Ordinance, 2016.

(2) It shall come into force at once.

2. *Insertion of new section 10D.*— In the Dentists Act, 1948 (hereinafter referred to as the principal Act), after section 10C, the following section shall be inserted, namely:—

“10D. *Uniform entrance examination for undergraduate and post-graduate level.*—

There shall be conducted a uniform entrance examination to all dental educational institutions at the undergraduate level and post-graduate level through such designated authority in Hindi, English and such other languages and in such manner as may be prescribed and the designated authority shall ensure the conduct of uniform entrance examination in the aforesaid manner:

Provided that notwithstanding any judgment or order of any court, the provisions of this section shall not apply, in relation to the uniform entrance examination at the undergraduate level for the academic year 2016-2017 conducted in accordance with any regulations made under this Act, in respect of State Government seats (whether in Government dental college or in private dental college) when such State has not opted for such examination.

3. *Amendment of section 20.*— In section 20 of the principal Act, after clause (h), the following clause shall be inserted, namely:—

“(ha) the designated authority, other languages and the manner of conducting of uniform entrance examination to all dental educational institutions at the undergraduate level and post-graduate level;”.

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Goa hereby makes the following rules to regulate the recruitment to the Group 'B', Gazetted, Non-Ministerial post, in the Directorate of Tribal Welfare, Government of Goa, namely:—

1. *Short title, application and commencement.*—

(1) These rules may be called the Government of Goa, Directorate of Tribal Welfare, Group 'B', Gazetted, Non-Ministerial post, Recruitment Rules, 2016.

(2) They shall apply to the post specified in column (1) of the Schedule to these rules (hereinafter called as the "said Schedule").

(3) They shall come into force from the date of their publication in the Official Gazette.

2. *Number, classification and scale of pay.*—

The number of posts, classification of the said post and the scale of pay attached thereto shall be as specified in columns (2) to (4) of the said Schedule:

Provided that the Government may vary the number of posts specified in column (2) of the said Schedule from time to time subject to exigencies of work.

3. *Method of recruitment, age limit and other qualifications.*— The method of recruitment to the said post, age limit, qualifications and other matters connected therewith shall be as specified in columns (5) to (13) of the said Schedule.

4. *Disqualification.*— No person who has entered into or contracted a marriage with a person having a spouse living or who, having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to the service:

Provided that the Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

5. *Power to relax.*— Where, the Government is of the opinion that it is necessary or expedient so to do, it may, by order, for reasons to be recorded in writing and in consultation with the Goa Public Service Commission, relax any of the provisions of these rules with respect to any class or category of persons.

6. *Saving.*— Nothing in these rules shall affect reservation, relaxation of age limit and other concessions required to be provided for Scheduled Castes and other special categories of persons in accordance with the orders issued by the Government from time to time in that regard.

These rules are issued in consultation with the Goa Public Service Commission conveyed vide its letter No. COM/II/13/70(l)/2016/136 dated 25-04-2016

-third month from the date of appointment of such Probationer. The Probationer who fails to clear the said examination even after the three attempts, shall be considered as being unable to complete the probation period successfully and his services shall be terminated forthwith.

(B) *For promotees on probation:—*

(a) The Officers promoted to the post of Junior Scale Officers of the Goa Civil Service shall attend a training for a period of forty-five days at GIPARD and after completion of the said training, they shall answer a departmental examination conducted by the GIPARD.

(b) The Officers who fail to clear the departmental examination in a first attempt shall be given another opportunity to appear for the examination after a period of six months. The Officers who do not clear the examination even after two attempts shall be given a last opportunity to answer the departmental examination after a period of six months. The Officer who fails to clear the said examination even after the three attempts shall be considered as being unable to complete the probation period successfully and he shall be reverted back to his original position from where he was promoted to the post of Junior Scale Officer.

(2) *Syllabus.*— The syllabus for the training and departmental examination shall be as specified in the Annexure appended hereto.

(3) *Passing Percentage.*— A candidate shall be declared as passed in the departmental examination, if he secures a minimum of 45% of the total marks in each paper.

This Notification shall come into force with immediate effect.

**Amendment to “The Scheme to Grant
Monthly Financial Assistance to the
Persons Engaged in Traditional
Occupation/Businesses including
Motorcycle Pilots.”**

Whereas vide Notification No. 82-6-07-08-SDB/Part-II dated 20-12-2012 published in the Official Gazette, Series I No. 23 dated 5-9-2013, and Amendment Notification No. 82-6-07-08-SDB/Part-II/4787 dated 15-10-2014 the Government of Goa framed the scheme, viz. “The Scheme to Grant Monthly Financial Assistance to the Persons Engaged in Traditional Occupation/Businesses including Motorcycle Pilots.”.

And whereas the Government has decided to amend the said scheme.

In the scheme the following amendments are carried out in clause ‘2’ after 4, 4 a will be inserted and read as:—

1. ‘Yellow/Black Auto Rickshaw Drivers’ means a person who is engaged in driving Yellow/Black Auto Rickshaw and solely dependent on carrying the trade for his livelihood and who possesses a valid License and Badge to drive Yellow/Black Auto Rickshaw issued by Directorate of Transport of the State Government.

2. In eligibility criteria at sub point No. 7 will be substituted as Attested copies of ownership documents of the vehicle such as Registration Certificate, Insurance, Fitness Certificate of the vehicle (for Motor Cycle Pilots/Yellow/Black Auto Rickshaw Drivers).

3. Point No. 9 will be substituted as Verification from the registered Motorcycle Taxi Association/Yellow/Black Auto Rickshaw Drivers Association in Annexure-III.

4. In Schedule B at point No. 6, Auto Rickshaw driver will be added and substituted as:—
